for the stud services of the stud dog listed above. The stud dog owner agrees to

breed the above listed AKC Registered Brittany to above listed AKC Registered

Brittany bitch, per the terms as listed below:

- 1) A \$150.00 (one hundred fifty dollars U.S.) non-refundable deposit is due and owing at the time of the actual breeding. This fee covers the cost of handling the breeding, regardless of whether puppies result from said breeding, and is due to the stud dog owner.

- 2) The balance of \$\_\_\_\_\_ (\_\_\_\_\_ dollars U.S.) is due at the time the owner(s) of the bitch wishes to have the registration papers signed by the stud dog owner for any resulting puppies.**
- 3) Because the stud dog owner has a vested interest in this litter, the bitch owner(s) agrees not to sell any of the resulting puppies for retail in a pet store, grooming parlor, or retail outlet, nor will the bitch owner(s) sell any resulting puppies for use in laboratory experiments of any kind.**
- 4) The bitch owner(s) is responsible for all veterinary expenses incurred by the bitch's resulting pregnancy and for the resulting litter of puppies. Additionally, any veterinary expenses incurred by the stud dog owner on behalf of the bitch, including but not limited to artificial insemination, collection or shipment of semen for this breeding, blood work, accident, illness or injury, shall be immediately paid by the bitch owner to the stud dog owner.**
- 5) Prior to the bitch being sent for breeding, proof of a current brucellosis test, proof of vaccinations, and a negative fecal must be provided in writing to the stud dog owner.**
- 6) The stud dog owner requires that the bitch be OFA hip certified, minimum, and it is further recommended that the bitch be OFA elbow certified, and possess a current CERF eye exam certification.**
- 7) The bitch owner is responsible for all expenses for transporting the bitch to the stud dog. If airline arrangements are made, the bitch owner will provide return shipping fees or proof of C.O.D. prior to the bitch being shipped back to her owner. Airline insurance for the bitch is the responsibility of the bitch owner.**
- 8) Acceptance by the bitch owner of this agreement via signature below implies that the bitch being bred is free from any known genetic defect, including but not limited to hip dysplasia, epilepsy, or congenital heart or eye defects.**
- 9) The stud dog owner and representatives of Rao Farms will provide reasonable and comfortable kennel accommodations, exercise, and diet to bitch while she is in the care of Rao Farms. Special diets, medication, vitamins, etc., are the responsibility of the bitch owner, and such additional costs shall be added to the amount due the stud dog owner.**

- 10) Stud dog owner will provide bitch owner with photo and four-generation pedigree of stud dog. Bitch owner(s) agree to provide stud dog owner with photo and four-generation pedigree of bitch.**
- 11) Rao Farms and its employees will exercise reasonable care and caution while bitch is in its care. However, Rao Farms and its employees will not be held responsible or liable for accidental death, illness or injury of the bitch while she is in transit to or from its owner(s), or while the bitch is residing on the premises at Rao Farms.**
- 12) It is the responsibility of the bitch owner(s) to provide stud dog owner with all information regarding the bitch's nature and personality regarding, but not limited to, aggressiveness, kennel behavior, eating habits, etc.**
